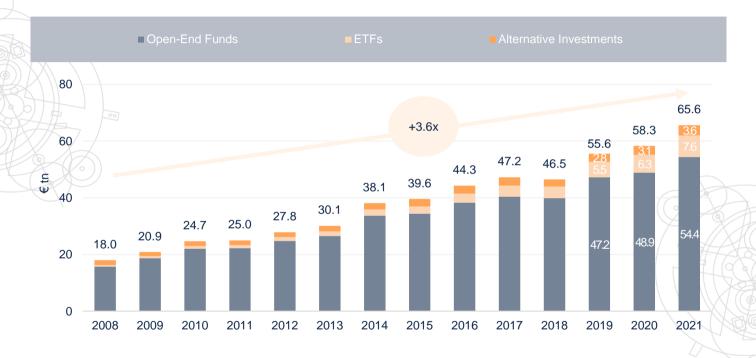

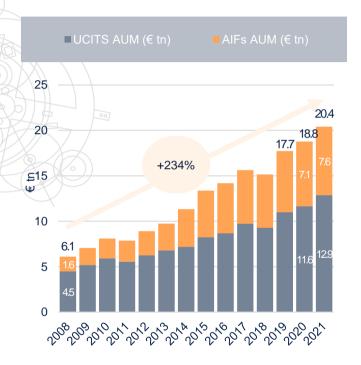

## Global Fund Assets 30/06/2021



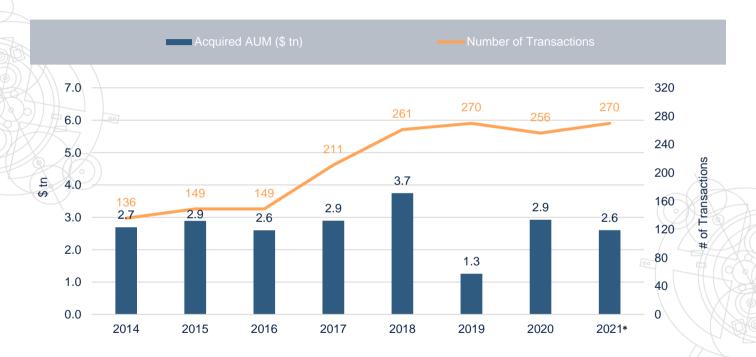
#### European Investment Fund Industry 30/06/2021

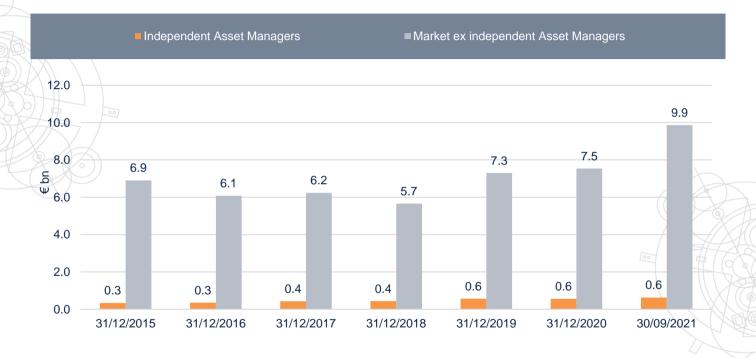

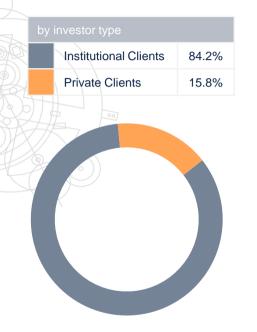


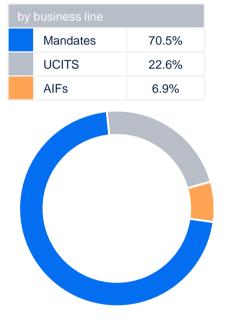


## Client breakdown evolution 30/09/2021



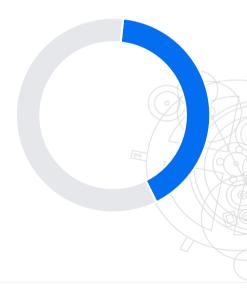
#### AUM Breakdown 30/09/2021

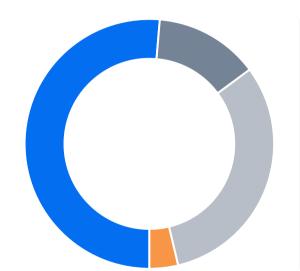

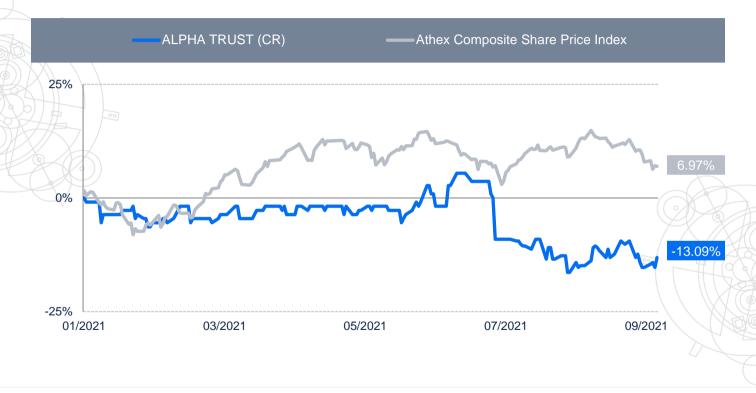

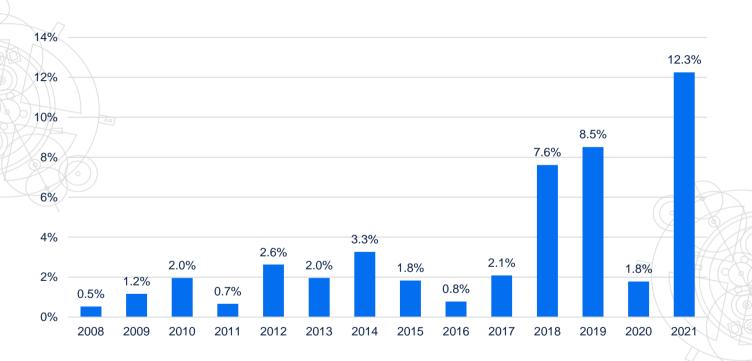
## Share performance YTD as of 30/09/2021
